The undersigned hereby releases, waives, discharges and covenants not to institute or prosecute any lawsuit against the Community Homeschool Center in Bryan, Texas, and LifeChurch or any of their agencies, departments, officers, employees, members or agents from all liability to the undersigned for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in the death or injury of the undersigned, whether caused by the negligence of the Community Homeschool Center or LifeChurch or otherwise, while the undersigned is in, upon, about or using the facilities or equipment of the facility.

The undersigned hereby agrees to indemnify and save and hold harmless the Community Homeschool Center, and LifeChurch in Bryan, Texas, or any of their agencies, departments, officers, employees, members or agents from any loss, liability, damage or cost the Community Homeschool Center, or LifeChurch in Bryan, Texas may incur due to the presence of the undersigned while the undersigned is in, upon, about or using the facilities or equipment of the Foundation whether caused by the negligence of the Community Homeschool Center, or LifeChurch in Bryan, Texas or otherwise.

The undersigned further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Texas and that if any portion thereof is held invalid, it is agreed that the remainder shall continue in full legal force and effect.
